**REQUIREMENTS FOR APPLYING TOURIST VISA**

1. Two completed application forms and one completed "Report of Arrival" form with a photo on each
2. An evidence of the trip -- copy of air ticket/ itinerary/ letter from the travel agent (required for Foreign Independent Traveler only)
3. Prepaid Self -Addressed Envelope (FedEx/ USPS-Express Mail/ DHL/ UPS/ AirBorne) (Payment arranged through Credit Cards are not accepted)
4. Passport of at least 6 months validity with available visa pages
5. Payment of US\$20 per applicant for visa fee, payable to the Embassy of Myanmar in official check, company check or money order only (personal checks are not accepted)

**(VISA INFORMATION)**

- . The Entry Tourist Visa is valid for a stay of exactly 4 weeks (28days) and not extendable.
- . Visas are valid for THREE MONTHS from the date of issue, which cannot be renewed or refunded.

**(VISA OFFICE HOURS)**

**Monday through Friday**

**- DROP-OFF - 9:30 A.M. - 12:00 NOON**

**- PICK-UP - 1:30 P.M. - 5:00 P.M.**

**Visa processing time is approximately 5 business days**
